Rakad Dance Camp Camper Behavior Contract

The following is a list of guidelines in place to ensure that participants of Rakad Dance Camp are able to have a safe and fun time at camp. Please read over this contract with your camper, sign the agreement, and bring it with you on the first day of camp. Thank you!

- **Embrace new experiences. Sometimes learning a new dance step can be hard, but try to do the best you can do. You may even find you like some of the new things you are trying at camp.**
- **Show respect for the camp leaders, camp chaperones, fellow campers, and yourself. This means refraining from foul language, failing to follow instructions, and/ or other inappropriate behaviors.**
- **Listen and follow any of the camp leader’s instructions; it’s for the safety of everyone involved at camp.**
- **Demonstrate kindness towards all campers. This means refraining from insulting, assailing, and/or acting negatively toward another camper or camp volunteer whether directly or indirectly.**

When campers exhibit poor behavior, we believe in addressing discipline issues head on, and using these moments to teach and educate our campers. The volunteers from Rakad Dance Camp will generally go through the following procedures. However, just as all campers are different, all disciplinary actions will require a unique course of actions. Consequently, this is just an example not the rule.

First Issue to Occur	Verbal Warning, discussion about behavior with Small Group Leader and/or Adult Volunteer
Second Issue to Occur	Written Activity, sit out from activities to complete, with Camp Director and/or Administrative Assistants, a written activity that addresses the behavioral issue
Third Issue to Occur / s	<ul style="list-style-type: none"> - Parent/Guardian called - Discussion with Small Group Leader AND Camp Director - Written apology - Possible dismissal from Rakad Dance Camp

These guidelines are in place to ensure the safety of everyone in attendance at Rakad Dance Camp. If any of these guidelines are not met or if the restrictions are broken, campers may not be able to participate in some camp activities such as dance technique, games, or crafts, because of safety concerns. If a camper is misbehaving to a severe degree, the camper’s parents/guardians may be called to pick up their camper early and their camper may be asked not to return.
